Chronic exposure may cause bronchitis, liver, kidney and pancreatic damage. Dichloromethane has caused carcinogenic, teratogenic and reproductive effects in laboratory animals. Memory loss, poor coordination, and reduced ability to think may result from brain damage. Dichloromethane may affect human sperm and can cross the placenta.

 Boron affects the central nervous system. Boron poisoning causes depression of the circulation, persistent vomiting and diarrhea, followed by profound shock and coma. The temperature may become subnormal and a scarletina form rash may cover the entire body.
